# Delhi to vote on February 5, counting on February 8: CEC Rajiv Kumar

New Delhi, Jan. 07: Assembly polls in Delhi will

be held on February 5 and the votes counted on February 8, Chief Election Commissioner Rajiv Kumar announced on Tuesday. The last date to file nominations is January 17 and the scrutiny of nominations will be done by January 18. Candidates will be able to withdraw their nominations till January 20. "It is a single-phase election... We have deliberately kept polling on a Wednesday so more people come out to vote... like we did in Maharashtra," Kumar said at a press conference. Bypolls to two assembly constituencies - Milkipur in Uttar Pradesh and Erode in Tamil Nadu - will also be held according to same schedule.Chief Election Commissioner Rajiv Kumar on Tuesday urged candidates and political party leaders to refrain from making remarks against women and involving children during poll

campaigns. Kumar, who was addressing a press conference to announce the assembly poll schedule in Delhi, was asked about the recent comment made by BJP leader Ramesh Bidhuri against Congress MP Priyanka Gandhi Vadra. Bidhuri, the BJP candidate from Kalkaii, sparked controversy when he had said he said. "Children should not be associated (with he would make the roads in his constituency "like campaigns) at all... ### 'Daraarvadi', 'Hridayheen': Akhilesh coins new sobriquets to target BJP

Lucknow, Jan. 07: Samajwadi Party chief Akhilesh Yadav on Tuesday coined two new sobriquets "Daraarvadi" (divisive) and "Hridayheen" (heartless) to target the Bharatiya Janata Party in Uttar Pradesh. Speaking to reporters at the party office here, Yadav said, "These BJP people in power are not in favour of brotherhood. It is a 'Daraarvadi' party. Human life does not hold any value for them, because they only want to use it to derive political benefits." "If you see BJP's work, you will notice how 'Hridayheen' it is. It doesn't have sympathy towards anyone. Many incidents are occurring in Uttar Pradesh despite the BJP's tall claims of running a zero-tolerance government,



Yadav said. Claiming that there are two sides to the BJP government in Uttar Pradesh, the Samajwadi Party (SP) chief said, "One is injustice towards PDA and the second is corruption, with both surpassing each other from time to time. To hide the imbalance, the BJP hatched a conspiracy to orchestrate violence in Sambhal. It was also done to hide the loot during the recent bypolls at Kundarki and Meerapur." 'PDA' is an acronym coined by Yadav for 'picchde, Dalit, alpsankhyak' (backwards, Dalits and minorities). Yadav also claimed that the leader of opposition in state Assembly, Mata Prasad Pandey, wanted to visit Sambhal and speak to the people there, but the BJP government imposed prohibitory orders. "However, when they (SP delegation) went for a second time, the same administration allowed them. It is not clear what the government wanted to hide," he said. Violence erupted in Sambhal during a survey on November 24 last year, as protesters gathered near the Shahi Jama Masjid and clashed with the security personnel, leaving four dead and several injured. "The government used its officials to trigger the violence in Sambhal. Otherwise, what was the urgency to conduct the survey," the SP chief asked. "You cannot conduct such surveys under the Places of Worship Act. Yet the government and its officials went ahead with it.

### **One Nation One Election:** Parliamentary panel to hold first meeting today

New Delhi, Jan 07: The parliamentary panel constituted to scrutinise the two simultaneous election bills will hold its first meeting on Wednesday, with officials of the Law and Justice Ministry scheduled to brief its members on the provisions of the proposed laws. The 39-member joint committee of Parliament is headed by BJP MP P P Chaudhary and includes members of all major parties, including Priyanka Gandhi Vadra of the Congress, Sanjay Jha of the JD(U), Shiv Sena's Shrikant Shinde, AAP's Sanjay Singh and TMC's Kalyan Banerjee. Chaudhary is a former minister of state for law. The Constitution (129th Amendment) Bill and the Union Territories Laws (Amendment) Bill were introduced in the Lok Sabha during the Winter Session and referred to the committee. The government decided to increase the committee's strength from 31 to 39 as more political parties expressed the desire to be part of the exercise to examine the two draft legislations on simultaneous elections. Former Union ministers Anurag Thakur, Parshottam Rupala and Manish Tewari and several first-term lawmakers, including Bansuri Swaraj and Sambit Patra, are also members of the committee.

### Abuse me or call me Dawood, but help Delhi farmers: Chouhan

New Delhi, Jan. 07: Agriculture Minister Shivraj Singh Chouhan on Tuesday urged Delhi Chief Minister Atishi to implement cen-

tral government farmer welfare schemes in the national capital, saying he was willing to weather personal attacks if it benefits Delhi's farming community. "Abuse me or call me Dawood, it does not make any difference to me, but implement the farmer welfare schemes of the Government of India for the farmers of Delhi, give them the benefit of the schemes," Chouhan said in a meeting with a group of Delhi-based farmers here. He requested the Delhi CM to submit proposals immediately and take central funds for implementation of the central

schemes. Chouhan's reference to Dawood Ibrahim, the notorious gangster, appeared to be a response to previous criticisms from Delhi's leadership. "I don't mind if you abuse me, but give the benefits of the schemes to the farmers... It is not in my nature to abuse anyone. With folded hands request you to implement the schemes," he said. Several central government schemes meant for farmer welfare have faced implementation hurdles in



Delhi, the minister said, adding that he had written to Delhi CM flagging this issue recently. "I am saying with great pain that the farmers of Delhi are not getting the benefit of many schemes of the central government. Farmers are not getting the benefit of subsidy being provided by the Centre," he said. The implementation of central government agricultural schemes in Delhi has been a point of contention between the Centre and the Delhi government. Several farmers at the meeting highlighted their exclusion from crucial programmes available in neighbouring states. Captain Kanwarlal Dagar, former national president, Bharatiya Kisan Union, said, "The farmer of Delhi, once considered the king of India, has become the most backward in the country, despite three master plans implemented over the last 40-50 years." Unlike farmers in neighbouring states, Delhi's agricultural community is excluded from crucial central government programmes such as the soil health scheme and crop insurance initiatives, said Satyawan Sehrawat, a farmer from Darya Pur Kalan village in northwest Delhi. They are also unable to access the substantial subsidies available for drip irrigation systems that farmers in adjacent states enjoy, he said, adding that while other states have implemented solar schemes to support agriculture, Delhi lacks such provisions.

### Collegium recommends Patna HC CJ K Vinod Chandran as top court judge

New Delhi, Jan 07: The Supreme Court collegium on Tuesday recommended Patna High Court Chief Justice K Vinod Chandran to be appointed as a judge of the apex court. The



India Sanjiv Khanna in a meeting held on Tuesday recommended the name of Justice Chandran, who was appointed as a judge of the Kerala High Court on November 8, 2011. Justice Chandran was elevated as the Patna High Court Chief Justice and has been serving the position since March 29, 2023. Given the Centre clears the recommendation, the Supreme Court judges' strength will rise to 33

compared to the sanctioned strength of 34 judges. Supreme Court judge Justice C T Ravikumar demitted office on January 3. "He has served as a judge of the high court for more than 11 years and as a chief justice of a

big high court for more than a year. During his long tenure as a judge and chief justice of the high court, Justice Chandran has acquired significant experience in diverse fields of law," said the collegium resolution. The apex court colegium also comprising Justices B R Gavai, Surya Kant, Hrishikesh Roy and Abhay Oka said Justice Chandran stood at number 13 in the combined all-India seniority list of high court judges. "In the seniority of judges hailing from the high court of Kerala, Justice K Vinod

Chandran stands at serial number 1. While recommending his name, the collegium has taken into consideration the fact that there is no representation on the bench of the Supreme Court from the High Court of Kerala. The collegium has, therefore, unanimously recommended that Justice K Vinod Chandran be appointed as a judge of the Supreme Court of India," the resolution said.

### Conman arrested for extortion attempt using ED officer's name in Hyderabad

HYDERABAD. The Hyderabad zonal office of the Directorate of Enforcement conducted searches on January 3 under the Prevention of Money Laundering Act (PMLA), 2002 and seized multiple SIM cards and mobile phones from the residence of alleged conman Sandeep Desai.The SIM cards and phones are believed to have been used in fraudulent activities targeting individuals under ED investigation. The January 3 searches were a follow-up to the ED's searches of two premises of CSK Realtors Ltd. and Singh Mansions Pvt. Ltd in Hyderabad on December 19, 2024.

Following the searches, Desai allegedly contacted Suresh Kumar Agarwal, the managing director of CSK Realtors and attempted to extort money. Desai arranged a meeting at a five-star hotel in Hyderabad, introducing himself as "Rakesh" and claiming to be a relative of an ED officer. He allegedly demanded a large sum to mediate with ED officials.Based on a written complaint from Agarwal, the ED launched an investigation. Surveillance and CCTV footage led the ED team to Desai.

During questioning, Desai admitted to the extortion attempt, falsely claiming connections with ED officers.

# Kerala State School Arts Festival: For SKV HSS students in Palode, Kalolsavam and money matter CHENNA. If you've visited a plant nursery recently, chances are you've

THIRUVANANTHAPURAM. A school tucked away in remote Palode in Thiruvananthapuram, sharing borders with hilly terrains and sprawling plantation space. A school where most students are from economically weaker sections and which itself is not affluent to fund its projects. Yet, SKV HSS in Nanniyode will not compromise on the opportunities it offers students. This Kalolsavam, 52 of its students are participating in 12 events, and are racking up 'A' grades in individual as well as group events, after months of practice for perfection.

However, every year, before they embark on the quest to be the best, the school and students have to take up another challenge - raising money for the props, costumes, trainers and everything else they would require for the fest."Participation in the Kalolsavam requires a minimum of Rs 6 lakh if we avoid star events like group dance. We have to shell out anywhere from Rs 50,000 to Rs 2 lakh for events like vattappattu, poorakkali, parichamuttu and drama," says political science teacher Aneesh M S, who also coordinates youth festival training and activities. Before Kalolsavam 2022, the school registered participation in stray individual events. After 2022, the students were motivated to take the Kalolsavam seriously.

However, funds remained a bother. Since most students are children of plantation workers, seeking money from them is not an option, says



Aneesh. "The school too lacks the wherewithal to fund it fully. So, we organise events such as money," he says. The training begins seven to eight months before the fest, when trainers arrive periodically to impart lessons. "The trainers must be of high quality for the students to win prizes at the Kalolsavam. They known our situation and hence, provide services on economical rates," says Aneesh.

'In between the training and classes, we split into groups, go out, and collect scrap from houses, which is then sold to raise money for the festival. This time, we conducted a coupon challenge and raised around Rs 1.5 lakh," says Ajin Krishna M S, a Class 12 student of SKV HSS competing in ottanthullal and other group events.

The remaining money is pooled in by the management, teachers, and students. However,

the students' activities ease the burden of the school and parents," says Aneesh.

# Kerala: CPI raises a toast to comrades, with rider

It was in its 1992 special national organisational conference in Thrissur that the CPI passed its first code of conduct. The party has revised the stand after 33 years. The new code of conduct, in possession of , however, clarifies that abstinence from alcohol is the CPI policy.

instructions in the party executive. "It is a stance taken to keep with the changing times," a senior CPI leader told TNIE on condition of anonymity. "If we decide to take a tough stand, where will we find cadre? The times have changed. We cannot prohibit anything, only control and reduce its impact," he said.

The new model code also instructed the cadre to lead a simple life and set a model to other party workers. People's representatives, from MLAs to local body members, should not approach the government with recommendations related to subjects of corruption and allegations.

"No one should pressurise or influence the government which is against the view and position of the party. MPs and MLAs should attend parliament and assembly sessions and report the summary of the proceedings to the party and the public. Cadre should not accept dowry. They should not be part of any rituals or programmes propagating superstition.

### Heavy police presence at Dharmapuri Collectorate as residents protest panchayat merger with municipality

DHARMAPURI. Preempting a possible protest in the collectorate by residents of A Jettihalli, Thadangam, Elakkiyampatti, and Sogathur opposing the merger of their panchayats with the Dharmapuri municipality, a huge posse of police was deployed at the collectorate premises on Monday. Further, officers brought five representatives from each panchayat in a police vehicle to submit a petition during the weekly grievances meeting and dropped them back home. Hundreds from A Jettihalli, Thadangam, Elakkiyampatti, and Sogathur panchayats have been visiting the collectorate in the last few days to submit petitions registering their objection to being part of Dharmapuri Municipality. On Monday, police received a tip-off that a large gathering would be at the collectorate.

As a precaution, over 70 police officers were deployed in front of the Collectorate. Speaking to, R Adhimoolam, a resident of Thadangam said, "People have not accepted the merger with the municipality. It will cripple the livelihood of farmers and farm labourers."S Gowramma, from A Jettihalli, said, "The state government never asked us if we want to be part of the municipality.

They just passed a GO and we are opposing it. Seeing the large number of police personnel gathering makes us feel like criminals," she said. When spoke to police officials stationed in the collectorate they said, "It is merely a precaution. If more than a hundred people gather, it would affect traffic flow and disrupt the proceedings of the grievance day meeting. Usually, only five people are allowed to represent the people because of limited space in the collectorate."In A Jettihalli, the residents staged a protest outside the panchayat office condemning the merger.

# Tiruchy corporation lost about Rs 7 crore clearing airport waste, shows RTI data

TIRUCHY. The Tiruchy municipal corporation has been losing significant revenue even as the Airports Authority of India shifted its burden of clearing garbage generated at the international airport here to the former in violation of rules, revealed an RTI enquiry filed by the The New Indian Express. The RTI response from the Tiruchy airport authorities also revealed the municipal corporation was not paid a single penny over the years for removing the garbage. The reply also confirmed the airport has violated the Solid Waste Management Rules, 2016, (SWM 2016) of the Government of India. Highly placed sources said the Tiruchy corporation lost about '7 crore due to this mismanagement (from 2017 onwards), According to SWM 2016, an entity generating over 100 kg of waste per day must establish its own recycling facility. Responding to the RTI query filed by TNIE, Airport Director and Public Information Officer G Gopalakrishnan said, "Tiruchy airport roughly generates about 750 kg of waste daily.

As a stopgap arrangement, the waste is presently being cleared by the Tiruchy corporation." The director added that the airport would soon start the operation of



a solid waste plant that can handle 1 tonne of waste per day. To the RTI query, "If the Tiruchy airport is giving waste to Tiruchy city corporation, how much money is it paying per month or year," the airport director said 'NIL.'Although TNIE asked whether the airport got any exception under SWM Rules, 2016, for passing the waste to Tiruchy corporation, the airport director was unable to point out any such exceptions. Highly placed sources in the corporation said the Tiruchy corporation, from 2017 onwards, insisted the airport establish a solid waste management system, but the airport keeps on pushing this matter, citing various excuses."It is a major transport location and an iconic spot. Thus, the corporation avoided taking action on the airport," a source said. This generosity of the local body compelled it to take the waste burden of the airport at a heavy loss. Ironically, the Tiruchy airport is one of the most profitable airports, recording a profit of about Rs 50 crore in the 2023-24 financial year.

But instead of levying tax on such profitmaking entities, the local body condoned its solid waste management violations. When TNIE raised this issue with Tiruchy Corporation Commissioner V

# Long-delayed Mulanthuruthy rail overbridge set to be opened to public soon

KOCHI. A serpentine queue of vehicles, especially during peak hours, is a common sight on the Mulanthuruthy-Chengolappadam stretch. For the key route has a railway line cutting across it. While the construction of a rail overbridge (RoB) started over a decade ago, the works got much delayed due to issues like land acquisition. Finally, the construction of the Rs 20.77-crore structure is nearing completion and is set to be thrown open to the public early next month, providing huge relief to the residents there and also the longdistance commuters travelling from Ernakulam to Kottayam and nearby regions via Chottanikkara. "Heavy traffic congestion

is a usual sight here, especially during the Sabarimala pilgrimage season. A lot of pilgrims visit the Chottanikkara temple and then proceed to the hill shrine. The railway gate (level cross 12) used to be closed at short intervals since it is located on the busy Ernakulam-Kottayam section. Frequent closures for maintenance works made things worse. Hence a RoB was a much-needed facility, the work on which incurred a long delay," said Reji A C, a local central structure on its land as early as 2013. However, the work on the approach roads, extending 450 m, got prolonged and the construction started only in December 2022.

### Week on, neighbour who killed friend for not talking to him held

Ghaziabad: A week after the body of a 25-year-old woman was found in Ghaziabad's Podium park, the police arrested her 35-year-old ex-lover for the murder. The accused was nabbed from Kaushambi after an armed encounter with the police on Monday morning.

Soni had gone missing around 6pm on Dec 31. Her body was found on the morning of Jan 1 with multiple stab wounds.On Jan 2, Soni's father filed a police complaint alleging that Neeraj Kumar, who lives with his wife and two children in their building, was in a relationship with Soni. Police suspect Kumar was unhappy as Soni had stopped talking to him after her marriage was fixed.

Indirapuram ACP Swatantra Singh said during checks around 1.30am on Jan 6, cops spotted Neeraj near a culvert in Vaishali. When asked to stop, he tried to run away. The police chased him, and he fired at them. Cops fired back and Neeraj sustained a bullet injury in



his right leg. Neeraj told his interrogators that Soni was his distant relative. He lived with his family in Bhovapur for about 5 years and works as a tailor in a company in Sector 68. Soni used to work as a domestic help and later began working with him in tailoring. They worked together for about 5 years, and soon got into a relationship, the ACP said."A few days ago, Soni's marriage was arranged in Faridabad. Neeraj claimed that Soni began pressuring him to marry her. When he refused, she threatened to kill herself and frame Neeraj for her murder. On Dec 31, they went to Podium park in Vaishali. Soni continued pressuring him to marry her and insisted on eloping. Neeraj then stabbed her with a knife multiple times, fled the scene and returned to his factory. When he came to dispose of the murder weapon, he was caught by the police,"

### Civic corporation to hire new company to take Gurgaon's waste to Bandhwari

Gurgaon. The MCG plans to engage a private company for transporting waste from secondary collection points across all zones to the Bandhwari disposal site. The project is budgeted at Rs 9.6 crore, for which the

tender was floated on Monday. "We are now going to hire one agency for the transportation of waste from our secondary collection points to Bandhwari. The new tender is aimed at streamlining the city's waste management system," an MCG official privy to the matter said.

Following the termination notice issued to Ecogreen in mid-June 2024, the civic body outsourced the city's door-to-door waste collection to a private contractor, and transportation of waste to Bandhwari was also handled by multiple private contractors. However, local residents expressed dissatisfaction with the inconsistent service quality provied by the current contractors. According to officials, a single private agency will now be appointed to ensure efficient waste transportation operations. According to officials, the contractor or agency hired must arrange transportation of all waste at their own expense, including compactors, dumpers, excavators, and loaders. The corporation has mandated that all vehicles used for waste transportation must be equipped with GPS and waste must be transported with proper covering.

The contractor is responsible for transporting segregated municipal solid waste from secondary collection points and transfer stations to material recovery and composting facilities. However, the request for proposal (RFP) does not specify that the agency will have to transport segregated waste to the Bandhwari landfill site. As per the scope of work defined by the MCG for the agency, the new agency should utilise bailing, compaction machines, or other appropriate technology to reduce volume and maximise space utilisation. The waste must be disposed of at the designated site in accordance with SWM Rules 2016. The contractor needs to plan routes in consultation with MCG and complete all waste collection before 12 pm daily. It was in Dec 2024 that the MCG sent the final termination notice to be served to Ecogreen to the urban local bodies (ULB) department for its approval. Once approved by the department, the civic body will send the notice to

# Pope Francis names first woman to head major Vatican office

Rome, Jan. 07: Pope Francis on Monday named the first woman to head a major Vatican office, appointing an Italian nun, Sister Simona Brambilla, to become prefect of the department responsible for all the Catholic Church's religious orders. The appointment marks a major step in Francis' aim to give women more leadership roles in governing the church. While women have been named to No. 2 spots in some Vatican offices, never before has a woman been named prefect of a dicastery or congregation of the Holy See Curia, the central governing organ of the Catholic Church. The historic nature of Brambilla's appointment was confirmed by Vatican Media, which headlined its report "Sister Simona Brambilla is the first woman prefect in the Vatican". The office is one of the most important in the Vatican. Known officially as the Dicastery for the Institutes of Consecrated Life and Societies of Apostolic Life, it is responsible for every religious order, from the Jesuits and Franciscans to smaller newer movements. In an indication of the novelty of the appointment, and the theological implications involved, Francis simultaneously named as a co-leader, or "pro-prefect," a cardinal: Ángel Fernández Artime, a Salesian. But the appointment, announced in the Vatican daily bulletin, lists Brambilla first as

"prefect" and Fernández second as her co-leader, which theologically is necessary since the prefect must be able to celebrate Mass and perform other sacramental func-

tions that currently can only be done by men. Brambilla, 59, is a member of the Consolata Missionaries religious order and had served as the No. 2 in the religious orders department since last year. She takes over from the retiring Cardinal Joao Braz de Aviz, 77. Francis made Brambilla's appointment possible with his 2022 reform of the Holy See's founding constitution, which allowed laypeople, including women, to head a dicastery and become prefects. Brambilla, a nurse, worked as a missionary in Mozambique and

led her Consolata order as superior from 2011-2023, when Francis made her secretary of the religious orders department. Her appointment is the latest move by Francis to show by example how women can take leadership roles within the Catholic hierarchy, albeit without allowing them to be ordained as priests. Catholic women do much of the church's work in schools, hospitals and passing down the faith to future generations. But

they have long complained of second-class tary general of the Vatican City State, become less willing to understand, accept status in an institution that reserves the priesthood for men. Francis has upheld the



hopes that women could be ordained as deacons. But there has been a marked increase in the percentage of women working in the Vatican during his papacy, including in leadership positions, from 19.3% in 2013 to 23.4% today, according to statistics reported by Vatican News. In the Curia alone, the percentage of women is 26%. Among the women holding leadership positions are Sister Raffaella Petrini, the first-ever female secreresponsible for the territory's health care system, police force and main source of revenue, the Vatican Museums, which are led

by a laywoman, Barbara Jatta. Another nun, Sister Alessandra Smerilli, is the No. 2 in the Vatican development office while several women have been appointed to under-secretary positions, including the French nun, Sister Nathalie Becquart, in the synod of bishops' office. Pope wraps up busy Christmas season by calling for culture of welcome in Christian communities: Pope Francis wrapped up a busy Christmas season on Monday by callng for the faithful to promote a culture of welcome and integration in their communities and reject discrimination. Francis presided over Mass in St.

Peter's Basilica to mark Epiphany. According to the Bible, the feast marks the day that three wise men guided by a star came to visit the newborn Jesus. Francis said the star, in guiding humanity to God, doesn't discriminate among ethnic, linguistic or national groups and is there for all. "We do well to meditate on this today, in a world in which individuals and nations are equipped with ever more powerful means of communication, and yet seem to have babies in the Sistine Chapel.

and encounter others in their diversity!" he said in his homily. God, he said, calls on Christians to reject anything that discriminates or excludes and discards people. He called instead for promoting "a strong culture of welcome, in which the narrow places of fear and denunciation are replaced by open spaces of encounter, integration and sharing of life; safe spaces where everyone can find warmth and shelter." Francis has long preached the Gospelmandated need to welcome the stranger, applying it to migrants in particular. The Epiphany Mass marked the end of a particularly busy Christmas season for Francis that also coincided with the start of the 2025 Holy Year. The once-ever-quarter-celebration of Christianity is expected to bring more than 30 million pilgrims to Rome over the next 12 months. The 88-year-old pope has a daunting schedule ahead greeting and ministering to them, alongside his other papal duties. And while he is wrapping up the Christmas season with Epiphany, he still has a busy week ahead. He'll deliver his annual foreign policy speech to the Holy See's diplomatic corps, host a final meeting with President Joe Biden and preside over the baptism of

### Congo will execute over 170 people convicted of armed robbery

Kinhasa, Jan. 07: More than 170 inmates on death row were flown from Congo's capital to a high-security prison in the north where they will be executed, Congolese authorities said. Seventy of the convicts were transported on Sunday, Congolese Minister of Justice Constant Mutamba said, adding to 102 other prisoners who have already been sent to Angenga prison in the northern Mongala province. The men have been convicted of armed robbery and are locally known as "Kulunas" or "urban bandits". They're aged between 18 and 35, Mutamba said in a statement. He did not say when the executions would take place. Some have welcomed the measure as a means of restoring order and security in the cities, while others are concerned about the risks of abuse and human rights violations. "We welcome this decision by the minister because it will help put an end to urban crime. From 8 pm onwards, you can't move around freely because you're afraid of running into a Kuluna," said Fiston Kakule, a resident of the eastern city of Goma. Espoir Muhinuka, a human rights activist, warned of the possibility of extrajudicial executions and called for a strict respect for judicial procedures and fundamental guarantees. He fears that political pressure could lead to unjust convictions and arbitrary executions. "The situation in the DRC is complex and requires a multidimensional approach. The fight against urban gangs must go hand in hand with efforts to combat poverty, unemployment and social exclusion, which are often contributing factors to crime," he said. Congo abolished the death sentence in 1981, but it was reinstated in 2006. The last execution took place in 2003. In March 2024, the Congolese government announced the resumption of capital punishment in cases of treason by military personnel. In May, eight soldiers were sentenced to death, and in July, 25 soldiers were convicted

# S Korea's military says North Korea fired missile into eastern sea

Seoul, Jan. 07: North Korea on Monday fired a ballistic missile that flew 1.100 kilometers (685 miles) before landing in waters between the Korean Peninsula and Japan, South Korea's military said, extending its heightened weapons testing activities into 2025 weeks before Donald Trump returns as US president. The South's Joint Chiefs of Staff said the midrange missile was fired from an area near the North Korean capital of Pyongyang and that the launch preparations were detected in advance by the US and South Korean militaries. It denounced the launch as a provocation that poses a serious threat to peace and stability on the Korean Peninsula. The joint chiefs said the military was strengthening its surveillance and defense posture in preparation for possible additional launches and sharing information on the missile with the United States and Japan. Japan's Defence Ministry said the missile landed outside its exclusive economic zone and that there were no reports of damage to vessels or aircraft. The launch came as US Secretary of State Antony Blinken was visiting Seoul for talks with South Korean allies over the North Korean nuclear threat and other issues. Blinken's visit comes amid political tur-

Starmer slams 'lies and misinformation' after attacks from Elon Musk London, Jan. 07: The billionaire Tesla CEO has taken an intense and erratic interest in British politics since the centre-left Labour Party was

elected in July. Musk has used his social network, X, to call for a new election and demand Starmer be imprisoned. On Monday he posted an online poll for his 210 million followers on the proposition: "America should liberate the people of Britain from their tyrannical government." Asked about

Musk's comments during a question session at a hospital near London. Starmer criticised "those that are spreading lies and misinformation as far

and as wide as possible," particularly opposition Conservative politicians in Britain who have echoed some of Musk's claims. Musk often posts on

X about the UK, retweeting criticism of Starmer and the hashtag TwoTierKeir — shorthand for an unsubstantiated claim that Britain has "two-tier

policing" with far-right protesters treated more harshly than pro-Palestinian or Black Lives Matter demonstrators. Recently Musk has focused on

child sexual abuse, particularly a series of cases that rocked northern England towns in which groups of men, largely from Pakistani backgrounds,

were tried for grooming and abusing dozens of girls. The cases have been used by far-right activists to link child abuse to immigration, and to

accuse politicians of covering up the "grooming gangs" out of a fear of appearing racist. Musk has posted a demand for a public inquiry into the

Washington, Jan. 07: President Joe Biden is moving to ban new offshore oil and gas drilling in most US coastal waters, a last-minute effort to block possible action by the incoming Trump administration to expand offshore drilling. Biden, whose term expires in two weeks, said he is using authority under the federal Outer Continental Shelf Lands Act to protect offshore areas along the East and West coasts, the eastern Gulf of Mexico and portions of Alaska's Northern Bering Sea from future oil and natural gas leasing. "My decision reflects what coastal communities, businesses and beachgoers have known for a long time: that drilling off these coasts could cause irreversible damage to places we hold dear and is unnecessary to meet our nation's energy needs," Biden said in a statement. "As the climate crisis continues to threaten communities across the country and we are transitioning to a clean energy economy, now is the time to protect these coasts for our children and grandchildren," he said. Biden's orders would not affect large swaths of the Gulf of Mexico, where most U.S. offshore drilling occurs, but it would protect coastlines along California, Florida and other states from future drilling. Biden's actions, which protect

waters, could be difficult for Presidentelect Donald Trump to unwind, since they would likely require an act of Congress to repeal. Trump himself has a complicated history on offshore drilling. He signed a memorandum in 2020 directing the Interior secretary to prohibit drilling in the waters off both

### Revenue officials thwart illegal grabbing of 300 acres in Telangana

SIDDIPET. Officials of the Revenue department prevented the grabbing of up to 300 acres of land in Ameenpur mandal of Patancheru. Noting that Ameenpur is one of the costliest mandals in the district, sources said several unidentified persons were attempting to grab the lands here by building fences around them."There are 625 acres of government land in Bommanakunta village of the mandal. Some persons, using the name of a senior politician, erected fences around 300 acres some of which was already sold," the sources revealed.Upon learning about it Sangareddy Collector Valluri Kranthi alerted the revenue officials and directed them to remove the fence immediately. Following this, the officials reached the spot and removed it using heavy machines.

'We have taken steps to remove fencing surrounding the government land and save it. In part, the police were asked to monitor the area during the nights and holidays to prevent any illegal occupations and constructions," the collector told.

This apart, about five decades ago the Revenue department issued Occupancy Rights Certificate (ORC) to about 356 farmers. However, the government took back the lands after it was learnt that some farmers were not tilling it.

When all the farmers approached the court, it said that ORCs of 242 farmers were genuine. Even after that, the farmers were not shown borders of their lands, an official informed. Exploiting the opportunity to grab the vacant lands, some persons executed sale deeds with the farmers.

HYDERABAD. The ACB has summoned BRS working president KT Rama Rao to appear before it on January 9 for questioning in the alleged Formula-E race case, without his legal team accompanying him.Meanwhile, the former minister has written to the Enforcement Directorate investigating allegations of money laundering and violations under the FEMA concerning the transfer of '55 crore to foreign companies - informing it that the High Court is set to pronounce its orders on his quash petition on Tuesday. Earlier in the day, he reached the ACB office along with his legal team but was stopped by the police who informed him that the advocates could not be allowed inside. An argument ensued and about 40 minutes later, Rama Rao handed over a written note and returned to the Telangana Bhavan, the BRS headquarters.In his note, Rama Rao told the ACB: "In your notice, you have not given details of the information and documents sought from me pertaining to the case. You are requested to give details of the documents sought from me pertaining to the case to enable me to take necessary action after being given reasonable time. Being a law-abiding citizen, I will cooperate in the matter subject to constitutional and legal rights as provided by law". ### Nine RSS workers sentenced to life for 2005 murder of CPI(M) worker in Kerala

KANNUR. Nine RSS workers were sentenced to life imprisonment by a court in Thalassery on Tuesday for the murder of a CPI(M) worker in this north Kerala district 19 years ago.Rijith Sankaran, a 25-year-old CPI(M) member from Kannapuram Chunda, was attacked and killed near a temple in Chunda on October 3, 2005 allegedly by RSS workers during a period of political tension between the two parties in the area. Rijith was walking home when the accused, armed with weapons, ambushed him and his friends near a well. Three of his friends were injured in the attack. On January 4, the Additional District Sessions Court in Thalassery found the accused guilty. There were a total of 10 accused in the case, one of whom had died in a road accident.

The convicts include Sudhakaran (57), Jayesh



(41), Ranjith (44), Ajeendran (51), Anilkumar (52), Rajesh (46), Sreekanth (47), his brother Sreejith (43), and Bhaskaran (67). The court found them guilty under various sections of the Indian Penal Code, including murder (Section 302), attempted murder (Section 307), unlawful assembly (Section 143), rioting (Section 147), wrongful restraint (Section 341).

## How Mavinmoodu became

THIRUVANANTHAPURAM. Thiruvananthapuram owes much of its prominence to its heritage buildings and important government head offices. Among these, the Secretariat stands tall in the city's centre, and the place where it is situated is known as 'Statue.'

As simple logic suggests, the name 'Statue' originates after the installation of the statue of T Madhava Rao, an important figure behind the Secretariat building and a leader of Thiruvananthapuram's bureaucracy for nearly two decades. As the erstwhile Dewan of Travancore, Madhava Rao played a crucial role in the modernisation of the region. Way back, this area was known as 'Mavinmoodu'. The name Mavinmoodu is linked to a mango tree that no longer exists, explains historian Vellanad Ramachandran. After its disappearance and the establishment of the Secretariat, the area was referred to by its new landmarks, such as Kacheri Nada or Kacheri Mookku.

With the statue's arrival, it became known simply as the 'Statue' junction."Construction of the Secretariat started at 'Mavinmoodu' under the leadership of engineer Walthew Clarence Barton. The Secretariat was inaugurated in 1869 during Ayilyam Thirunal's reign. The statue of T Madhava Rao was installed in 1894, two decades after his tenure as Dewan, which lasted from 1857 to 1872. The statue, modelled as if he is gazing at the Secretariat, was sculpted by an Italian artist," explains historian Vellanad Ramachandran.It was since 1893, the area became known as 'Statue.' Before that, for a short period, it was known as Kacheri Nada. "The Secretariat itself had two names: it was initially referred to as Puthenkacheri, and later as Hajur Kacheri, giving rise to the name Kacheri Nada."There are similar examples of place names changing with new developments. The old name for the Medical College area was Kuzhiyathu Mukku. When an institution was established there, it took on a new name. "Another example is 'Poonthi' which means marshland. After a temple was constructed, it became Kumarapuram.' Ramachandran says. According to him, old names are rare in the city nowadays. "Most place names emerged during the colonial period.

# Nilambur MLA Anvar vows to join hands with UDF to take on Pinarayi Vijayan govt

THIRUVANANTHAPURAM. The Thiruvananthapuram branch of the Kerala Government Medical Officers Association (KGMOA) withdrew its decision not to join State School Arts Festival duties, following talks between their representatives and the additional chief secretary. The latter gave assurance that the doctors' demand for reinstating Dr D Nelson who was transferred to Adoor General Hospital as a punishment would be reinstated.

The withdrawal of non-cooperation came as a relief for the department which was struggling to find alternative

arrangements to run the camps in the festival venues. The department formed 6 to 24 medical teams to manage health care in the venues till January 8. The medical team at the venues



operates in two to three shifts, starting from 9 am. Drawing doctors and paramedics from family and community health centres to the arts festival is likely to impact the OP activities of these centres during the festival period. The KGMOA representatives, however, said that their protest against the arbitrary action shall continue despite the agreement to become part of the medical team."We will continue to boycott all additional duties till our demand is met. It should not have been dragged in this manner," said Dr Padmaprasad P S, district president of KGMOA.

The doctors started the protest after Dr Nelson was suspended in September last year following media reports that he was involved in private practice. Though the charge was proved wrong,

the doctor was transferred to a far-off location. As a result, the protest dragged on as DHS did not heed the demand for his reinstatement though the district has six vacancies.

### Human skull, bones found in fridge of an abandoned house in Kochi

KOCHI. A human skull and bones were discovered from the refrigerator of a deserted house in Chottanikkara during a police inspection following complaints by local residents of antisocial activities. The house, which belongs to a medical practitioner, had remained locked for around 25 years, police said. The discovery of skeletal remains has triggered speculation of black magic or other such illegal practices. Police said a detailed investigation will look into all possible angles. According to an officer, the house owner, Philip John, 74, who resides in Vyttila,



had not used the property, located at Palace Square, for over two decades. The abandoned house, located on 14 acres of land, had reportedly become a hideout for antisocial elements. Concerned local residents and ward councillor filed a complaint with Chottanikkara police. Acting on the complaint, police inspected the premises and uncovered the skull and bones in the refrigerator."Preliminary examination confirmed that the remains are human. We have summoned the owner for questioning. His children live abroad. A thorough investigation is underway to uncover more details," a police source said. "A case has been registered, but further details cannot be disclosed at this time. The forensic examination is scheduled for Tuesday, and more information will emerge after that," Ernakulam Rural police chief Vaibhay Saxena said.

# Madras HC bins detention of 18 accused in Kallakurichi hooch tragedy under Goondas Act

CHENNAL. The Madras High Court has quashed the orders for invoking the Goondas Act against 18 accused in the Kallakurichi hooch deaths on the grounds of delay of invoking the Act, non-furnishing the documents in the language the accused are familiar with and long incarceration.

"The law of preventive detention is draconian. It infringes upon the liberty of a person, a fundamental right enshrined in the Constitution. Therefore, the law shall sparingly be invoked if only the detaining authority forms an opinion that there is likelihood of breach of public order," a division bench of Justices SM Subramaniam and N Jothiraman observed while quashing

the detention order. The bench said it did not find any serious lapses in invoking the Act after the incident which happened on June 18 and 19 and caused public disorder. However, it noted that there has been an "enormous delay" in invoking the Act, which, according to the Supreme Court, is a ground for setting aside the order of detention.Besides, the documents were not translated into the language some of the detenues are familiar with, thereby causing "prejudice". The bench said they have been

and quashed the order. However, it added that the investigating agency, CBI, can incarcerated already for five to six months, oppose bail when it finds it necessary. The

orders were passed on the habeas corpus petition filed by the relatives of the detenues

Advocate General P S Raman urged the court to consider whether the detenues' action caused a breach of public order or not. He enlisted the number of cases registered by the prohibition enforcement wing and the persons arrested in prohibitionrelated crimes. However, the bench said the police are foisting cases and proxies are made available for arrest

for up to Rs 500 per day for their families' expenses, thereby helping the real culprits to roam freely.

The collection of contemporary masters in the museum, about 1,200 artworks, was curated by none other than Chandigarh's beloved son and internationally acclaimed art historian, BN Goswamy, who wrote a much-read column for The Tribune until he passed away a year ago. Moreover, I am now a card-carrying member of the City Beautiful. I realise I am in the presence of both History and Culture, both H & C capitalised.

Kulwinder strides in. His angry movements disturb the cold air of the gallery — so far it's been just me and the masters. Ramachandran's brooding painting of monks in a church seems like it's part of the Andrei Rublyev school. The attendant, who prefers warming her hands on the heater in the reception area, tells me, "Bahut log aate hain museum main", at least 10-12 every day. I ask Kulwinder if there is a guide. I don't know, he replies sternly, "main technical se hoon".

If Chandigarh is what Delhi was 40 years ago, then you can well imagine its museums - hidden jewels encrusted by sarkari indifference. The Government Museum and Art Gallery in Sector 10, designed by Le Corbusier himself, has that gorgeous wooden door that turns on a single pivot - you also see this large door in the conjoined Haryana-Punjab Legislative Assembly space that Corbu designed at one end of the Capitol Complex, itself a magnificent plaza that should have been teeming with happy people and moongphali-wallahs in the winter but has, instead, been turned into an exclusive zone in the name of security, which means only VVIPs and registered visitors have access — but the real experience begins when you go through the Corbu door into the Government Museum. The only available brochures are in French. (Corbusier was Swiss-French, so those folks come, it seems.) The English ones "are finished". The guide — her name is Geetanjali — walks up the ramp with me. On one wall hangs a gorgeous rope installation by Mrinal Mukherjee, except the bottom is frayed. stunned by the bronzes, the Sanghol excavations, the Gandhara sculptures and the Pahari paintings in the rooms beyond. Seems MS Randhawa, widely acknowledged as Chandigarh's First Citizen, scoured the estates of the small princelings soon after Independence and requested them to part with their treasures so they could become the heart of the Art Museum. And that's how BNG — as all of North India lovingly called BN Goswamy - revolutionised our understanding of our own heritage.

### Echoes of the Shikra, the tiny bird with a lion's heart

Shikras are found everywhere — from gardens in urban centres like Delhi and Bengaluru to rural countryside, and even open forests

I heard them for the first time on the day lockdowns began. As the world around me went silent, I had the time and the mindspace to listen to bird notes. The call of the Shikra can be quite dramatic if you hear it in silent woods. The loud 'Kekey keee' almost echoes off the tree stumps and shakes the dew off the leaves. The Shikra is a small bird of prey, one of the smallest, but with a big heart and a lot of courage, as I was to discover through the six months I spent on our farm during the lockdowns. A female Shikra is a little smaller than a house crow, but built like a warrior. Her back is rusty grey, and her belly is barred in rufous bands. Her eyes are golden yellow, the same colour as her legs. Among raptors, the females are larger than the males. A male Shikra is smaller and has a steel-grey back and barring similar to the female, but his eyes are blood red, almost demonic.Lockdowns were hard, even on a farm. My family and I were fortunate to be on a farm and hence able to wander outside the house a little. The real stress was not about being locked inside, but the anxiety of not knowing what would happen. I spent the first day thinking about it and wondering how to keep myself occupied. And just then, the Shikra answered my question. I heard their call coming from a Dalbergia tree that stood not far from our balcony. I had seen lots of Shikras over the years, but this call felt different. When I peered closely, I realised why: a female was sitting in a nest built with a ragtag bunch of sticks where two branches stuck out of the main trunk. The moment I saw her, I knew she was sitting on eggs. The call I heard was the male calling from a nearby tree. He had brought a freshly killed garden lizard. The female responded to his call and left the nest to eat the food he had brought. He passed the bloodied carcass to her on the nearby Neem tree and flew to the nest. At first, I thought he would take a turn incubating the eggs, but no — he just peeped in, made sure all was okay, and flew away. The female tore the flesh from the lizard's carcass until nothing was left - not even claws, skin, or scales. That was when I knew I wanted to know everything about the Shikra pair.

Shikras are very successful birds across the Indian subcontinent. They are found everywhere — from gardens in urban centres like Delhi and Bengaluru to rural countryside, and even open forests. They don't occur in the very deep rainforests, the high mountains, or the driest deserts, but other than that, they can be found everywhere. Still, I could hardly



find anything to read about a nesting pair of Shikras. started watching the nest for a few hours every day. Covid-19 spread across the country, and my thoughts went deeper into the life of the Shikra. I believed it was not healthy to delve too much into something as grim as a global influenza pandemic.


The first 'discovery' I made was that the female spent over 95 per cent of her time incubating the eggs in the nest. The rest she spent eating the food the male brought for her. It was a finding that made me uncomfortable. I did not want to talk about it with my others on the farm. It would only reinforce the stereotypes about the place of females in society.

The male was a good hunter. He brought a lizard, a squirrel, or a little bird every waking hour of the day. I named him Sheru. I thought that was a good name for a proficient hunter like him. Just when I thought the Shikras were settling into a domestic life, where the female looked after the little nestlings and the male provided for them, my perception of their life changed. A large eagle — a crested serpent eagle made an appearance against the bright blue sky on

the horizon. It was mid-morning, and the summer sun was creating upward drafts of hot air rising from the black cotton soil of the ploughed farms. This is the eagle's forte. Like a fighter jet, this sky belonged to the eagle. Sheru saw the eagle first. He flew to the top of a banyan tree and called his trademark 'Kekev keee', but this one had a different ring to it. In a split second, there was a response — a loud response from the nest. The female, a good 20 per cent larger than Sheru, rose out of the Dalbergia tree, gave a war cry of a call, flapped her wings, and blocked the sun in my eyes for a moment. Sheru followed her. The female did not wait for him; she was directly in between the eagle and the nest. Sheru joined her, and they were a team. Pound for pound, the eagle was bigger than the two of them together, and yet it chose to steer clear. She, the Shikra, flew around for a couple of minutes and then returned to her nest to incubate the eggs while Sheru went on patrolling for longer and then headed to a wooded grove to hunt again.An image of Shikra domesticity had taken form in my mind, and now it was broken. I felt free.

These dismissals, however, point to a larger issue: systemic

A systemic overhaul is vital to prevent further breaches of ethics and responsibility. Strengthening accountability mechanisms, ensuring transparent internal investigations and instituting independent oversight are critical. The emphasis on zero tolerance must extend to higher ranks, leaving no room for impunity. Public perception of the police hinges on integrity and discipline. While the recent actions in Punjab and Haryana are commendable, they must evolve into sustained reforms. Only then can law enforcement reclaim its role as a pillar of justice and rebuild

its image in the eyes of the public.

## Supreme Court must review its order on credit cards

Setting aside the 30 per cent cap on interest rates has severely hurt the interests of millions of credit card users in the country

The recent verdict of the Supreme Court, setting aside the 30 per cent cap on credit card interest rates imposed by the apex consumer court in 2008, has severely hurt the interests of millions of credit card users in the country, in more ways than one.

First of all, the clear message from the top court was that credit card companies were at liberty to charge any rate of interest on card dues. It said, "The mere inflation in the rates of interest cannot be construed as a practice intended to cause loss or injury." The credit card companies are at present charging a whopping 42-53 per cent per annum on dues, besides penalties on late payment.

Second, it gave a clean chit to credit card companies on their contracts and disclosures, by observing that "the banks have in no manner made any misrepresentation to deceive the credit card holders" and, therefore, cannot be accused of unfair trade practices. Third, in one stroke, it curtailed the power of the highest consumer commission vis-a-vis banking services. "A policy decision pertaining to the rate of interest and trade practices carried out by the banks across the country is a regulatory function within the specific statutory domain of the Reserve Bank of India (RBI) and cannot come under the purview of judicial scrutiny by the National Commission," the Supreme Court said (HSBC vs Awaz, December 20, 2024).

Not just consumer justice, but also the Directive Principles of State Policy enshrined in the Constitution required that the court take into consideration the ground realities, including the usurious rates of interest being charged by banks on credit card dues, and the harm caused to consumers as a result. It was also important to take into account



how credit card companies and online marketplaces are together pushing consumers into buying more and spending more, with a number of incentives such as 'buy now, pay later' offers and instalment schemes, resulting in consumers spending beyond their means. Today, with cards 'saved' on ecommerce sites, it is so easy to buy goods anytime and anywhere that consumers are becoming habituated to spending via cards; rather, they are becoming compulsive shoppers. In the absence of consumer education and financial literacy, it is easy in these circumstances for the consumers to fall into a

debt trap. Unable to cope with such a situation, many youngsters are today suffering from depression, at times leading to suicides. The result can be seen in the increasing rates of defaults. As of June 2024, credit card outstanding dues amounted to about Rs 2.7 lakh crore, up from Rs 2.6 lakh crore in March 2024 and more than Rs 2 lakh crore in March 2023. Similarly, credit card NPAs (non-performing assets) grew by 136 per cent in June 2024 when compared with March 2020. A poignant letter written by a consumer on a website describes this situation best — he says he has a debt of Rs 10 lakh on his credit card, half of which is interest and charges. He has been paying 90 per cent of his salary towards repayment but is unable to wipe out the debt. "Unable to cope, thoughts of suicide are constantly running in my mind," he says. Such cases are many and are increasing. In February last year, a couple in Hyderabad committed suicide, unable to pay their credit card dues. As of October 2024, the number of active credit cards in the country stood at more than 100 million. The situation vis-a-vis credit cards today is very different from what it was when the National Commission gave its judgment 16 years ago — and there is an urgent need to take a fresh look at all these factors and prevent a whole generation of Indians from becoming compulsive shoppers, incurring huge debts. Given this scenario, the Supreme Court had a responsibility to nudge the regulator to take immediate steps to reverse these trends before it was too late. It was an opportunity lost.

Certainly, fixing a maximum limit requires detailed inputs from all stakeholders and experts and the apex court could well have asked the regulator to constitute a committee and examine the issue in depth, and come up with adequate measures to protect consumers, without adversely affecting the credit card business. That would have also brought about transparency in the way the banks calculate the

rate of interest. Unfortunately, this was not done. However, it is not too late — the apex court must review its order and the Union Ministry of Consumer Affairs should file a curative petition. Consumers, in turn, should remind the RBI that it has to take their interest too into consideration while formulating policies vis-a-vis credit cards.

# 95 dead, 130 injured after multiple earthquakes in Tibet; tremors felt in India

**Tremors** were felt in Delhi-NCR and many parts of North India on Tuesday following a 7.1 magnitude earthquake in Tibet, near the Nepal border.

NEW DELHI. At least 95 people were killed and more than 130 injured as six earthquakes, including a powerful one measuring 7.1 on the Richter scale, rocked Tibet in one hour on Tuesday. The earthquakes shook buildings in many areas in India, Nepal and Bhutan.News agency Reuters, citing local media, reported that at least 95 people were killed in the Shigatse region of Tibet in the earthquake. China's state media said that 130 others were injured.Several buildings also collapsed near the epicentre, according to Chinese media. "Dingri county and its surrounding areas experienced very strong tremors, and many buildings near the epicentre

CCTV said. Shigatse is home to 800,000 people and the traditional seat of the Panchen Lama, one of the most important figures in Tibetan Buddhism.Strong tremors were felt in Delhi-NCR and various parts of North India, including Bihar's capital Patna and multiple

confirmed to me that it was an earthquake. I then hurriedly called my child and evacuated the house and went to the open ground," Meera Adhikari, a resident of Kathmandu, told news agency ANI.

According to the National Centre for Seismology, the first 7.1 magnitude earthquake struck Xizang, near the Nepal-Tibet border, at 6:35 am. This intensity is considered strong and is capable of causing severe damage. Chinese officials recorded the magnitude at 6.8 in Shigatse city, Tibet's second-largest city. Two aftershocks of 4.7 and 4.9 intensity were reported from the same Xizang area.

The epicentre was located where the India and Eurasia plates clash and cause uplifts in the Himalayan mountains strong enough to change the heights of some of the world's tallest peaks. According to China's state broadcaster CCTV, there have been 29 earthquakes with magnitudes of 3 or higher within 200 km of Shigatse city in the past five years, all of which were smaller than the one that struck on Tuesday morning.

### Be alert on HMPV: Govt urges hospitals to improve preparedness

However, authorities assured the public that the situation in the country is under control

NEW DELHI. Five years after COVID-19 overwhelmed global healthcare systems, a new flu-like illness, Human Metapneumovirus (HMPV), has recently gained attention following its outbreak in China. However, Indian authorities reassured the public on Monday that the situation in the country is under control, with no reported cases of the virus so far.

Director-General of Health Services (DGHS) Dr. Atul Goel emphasized that there is no need to panic. "HMPV is similar to other respiratory viruses that cause flu-like symptoms, primarily affecting the elderly and children," he said.

Respiratory illnesses are common during winters, and our hospitals are well-equipped to handle them," he added. The outbreak in China has seen a surge, particularly among vulnerable groups, leading to comparisons with COVID-19.Dr. Goel, however, dismissed fears of a similar scenario in India. "We have thoroughly analyzed respiratory illness data, including December 2024 trends, and found no significant rise in cases. The Indian Council of Medical Research (ICMR) confirms that there is no widespread outbreak in any part of the country," he said.

He further advised people to follow general hygiene practices to curb the spread of the virus."Take general precautions we use against all respiratory infections. People with cough and cold should avoid crowded places to prevent transmission. Use a separate handkerchief or towel for sneezing and coughing, and take basic medicines for cold or fever if needed," he said.

Meanwhile, the Delhi government on Monday directed all hospitals in the capital to remain fully prepared to manage a potential surge.In a directive marked "Most Urgent," Delhi Health Minister Saurabh Bharadwaj instructed the health and family welfare department to closely monitor the situation and remain in constant touch with the Union health ministry for timely

'Hospitals under the Delhi government must be fully equipped to handle any potential increase in respiratory illnesses, as advised by the Union health ministry," the directive stated.

The health secretary has been tasked with inspecting three government hospitals daily and submitting detailed reports on key parameters such as the availability of medicines as per the essential drug list, ICU beds, and the operational status of PSA oxygen plants and radiological

# Rape convict Asaram Bapu gets

NEW DELHI. Amid the Human Metapneumovirus (HMPV) scare, health experts have urged people not to panic, noting that the virus has been circulating globally for decades and is not a new threat. Specialists emphasized that the situation in India remains under control, with no confirmed reports linking the cases to the strain in China.Dr. Sumit Chakravarty, Associate Director of Paediatrics & Neonatology at Asian Hospital, said that HMPV is an old virus known to cause mild infections, often manifesting as a cold or flu-like illness. "In the past, it has been associated with pneumonia in children, but in most cases, the infection remains minor," he said.

However, Chakravarty stressed the importance of further studies to shed light on the potential for different strains circulating in India.Dr. Satish Koul, Senior Director of Internal Medicine at Fortis Memorial Research Institute, clarified that HMPV has been in circulation for many years and is most prevalent during the winter months.

The symptoms are very similar to the common flu. However, only a doctor can differentiate between flu and HMPV infection," he said. While no vaccine exists for HMPV and no definitive treatment has been established, experts recommend symptomatic care.

In terms of prevention, experts noted that the virus spreads through respiratory droplets. Simple hygiene practices, such as wearing masks and washing hands regularly, can reduce transmission.

# Where Is Atul Subhash's Son? Nikita Singhania's Lawyer Replies In Top Court

Thirty-four-year-old Atul Subhash died by suicide in December after accusing Nikita and her family members of harassing him and his parents by filing false cases against them

New Delhi. Ending weeks of suspense over the whereabouts of AI techie Atul Subhash's four-year-son, his estranged wife Nikita Singhania told the Supreme Court today that the child is at a boarding school in Haryana's Faridabad. Nikita's lawyer added that the child would be

taken to Bengaluru where he can stay with his mother. Thirty-four-year-old Atul Subhash died by suicide in December after accusing Nikita and her family members of harassing him and his parents by filing false cases against them. Nikita, her mother Nisha, and her brother Anurag are facing an abetment to suicide case and are currently out on bail.

Atul's mother Anju Devi has approached the Supreme Court, seeking custody of her grandson. Nikita's lawyer told the court today that the four-year-old had been

enrolled in a Faridabad boarding school and was there during her mother's arrest and subsequent bail. The child will, however, need to be shifted to Bengaluru because Nikita needs to be there as per the conditions of her bail."We will take the child to Bengaluru. We have taken the boy out of school. The mother has to remain in Bengaluru to fulfill bail conditions," her lawyer told the bench of Justice BV



Nagarathna and Justice N Kotiswar Singh. The bench then directed that the child must be produced in court in the next hearing. The lawyer representing Anju Devi told the court that as the grandmother, she should be given custody of the child. The lawyer said a child below six should not be sent to a boarding school.

The bench also noted that the child has barely spent time with his grandmother.

"Sorry to say but the child is a stranger to the petitioner," Justice Nagaratna remarked. Anju Devi's lawyer said they have pictures of the grandmother interacting with the child when he was two years old. Atul and Nikita married in 2019 and had a son the next year. In 2021, Nikita left their Bengaluru home after an altercation and in 2022, she filed a case against Atul and his family members. The court also stressed that Nikita Singhania is yet to be proven guilty and that it can't decide the matter based on a "media trial". The bench said that the issue of the child's custody will

have to be taken up in the appropriate court where the trial is on. The next hearing on the matter is on January 20.Atul Subhash died by suicide at his Bengaluru flat on December 9. In an 81minute video and a 24-page suicide note, the techie accused Nikita and his family members of filing false cases against him and his parents to extort money from them. ### Government mulls mandatory hallmarking for silver jewellery

New Delhi, Jan. 07: Food and Consumer Affairs Minister Pralhad Joshi on Monday asked the Bureau of Indian Standards (BIS) to consider implementing mandatory hallmarking for silver and silver artifacts following consumer demands. "There is a demand from consumers for mandatory hallmarking of silver. You (BIS) can deliberate and take a call," Joshi said at the 78th BIS Foundation Day event. The work in this direction has already begun and the government will take a decision after completion of stakeholder consultations and feasibility assessment by BIS, the minister told reporters on the sidelines of the event. "I have asked BIS to work out feasibility and take reactions from consumers and ornament dealers. We will consult all stakeholders and start the process," he added. Silver hallmarking, which certifies the purity of the white metal, is currently voluntary. BIS Director General Pramod Kumar Tiwari told PTI that the Bureau could be ready to implement mandatory silver hallmarking within 3-6 months, adding that the stakeholder discussions were underway. "Several rounds of discussions were held with stakeholders and they are in favour of it. The discussion on printing a unique sixdigit alphanumeric code is going on," Tiwari said. The move follows successful implementation of mandatory gold hallmarking introduced in June 2021, which now covers 361 districts. The existing system includes a unique six-digit alphanumeric code (HUID) certifying gold purity. According to the minister, about 90 per cent of jewellery being purchased is now hallmarked. More than 44.28 crore gold jewellery items have been hallmarked with unique IDs since the launch. Stakeholders from Gujarat, Karnataka and other states have requested the extension of mandatory hallmarking to silver, the minister added. BIS, established under the BIS Act in 1986, is an autonomous national body responsible for setting quality standards for products and services. Listing out upcoming focus areas, the minister said the BIS is also developing standards for Artificial Intelligence (AI) and is at the forefront of shaping the future of innovation and technology.

### Trade Unions demand hike in minimum EPFO pension to Rs 5K

New Delhi, Jan. 07: Trade Unions on Monday pressed for increasing minimum EPFO pension 5 times to Rs 5,000 per month, immediate constitution of the 8th Pay Commission and higher taxes on super rich in the upcoming 2025-26 Budget. In their customary pre-budget meeting with Finance Minister Nirmala Sitharaman, trade union leaders also demanded an increase in income tax exemption limit to Rs 10 lakh per annum, social security scheme for gig workers, and restoration of old pension scheme (OPS) for government employees. The Budget for 2025-26 will be presented by Finance Minister Nirmala Sitharaman on February 1 Talking to reporters after the meeting TUCC National General Secretary S P Tiwari said the government should stop all privatisation and corporatisation of PSUs and impose an additional 2 per cent tax on super rich to fund social security for informal workers. Tiwari also demanded that agriculture workers be extended social security and their minimum wages should also be fixed. Bharatiya Mazdoor Sangh Organising Secretary (Northern Zone) Pawan Kumar said that the minimum pension under EPS-95 should be increased from Rs 1,000 per month to Rs 5,000 monthly as a first step and subsequently linked to the VDA (Variable Dearness Allowance). It owns companies such as JK Tyre, JK Paper, JK Fenner, and Umang Dairies besides JK Lakshmi Cement. Shukla said the JK Organisation is exploring to invest in other sectors as well like tyre and paper manufacturing. "JK Organization is quite a diversified group. And the objective was to really explore other opportunities as well," Shukla said, adding that the group will decide on further investments after studying all aspects.

### Nick Kyrgios named in Australia's Davis Cup squad in surprise call-up

New Delhi. Star Australian tennis player Nick Kyrgios has received an unexpected call-up for Australia's Davis Cup clash against Sweden. Kyrgios, who has struggled with injuries in the recent past, was selected by captain Lleyton Hewitt for the clash, which is scheduled to take place at the end of January.

The 29-year-old was selected alongside world number eight Alex de Minaur, Jordan Thompson and Thanasi Kokkinakis in the Australian line-up for the clash in Stockholm on Jan. 31 and Feb. 1. Kyrgios has been picked despite struggling for fitness since 2022 due to knee, foot and wrist injuries.

Kyrgios spoke about his injury issues ahead of the Australian Open and said that he



needs a miracle to have his wrist in full fitness for the first Grand Slam of the year. The tournament begins on January 15 with the men's final scheduled on January 26.Kyrgios' inclusion in the Davis Cup squad could see him rekindle his doubles partnership with Kokkinakis, with whom he won the men's doubles title at the Australian Open three years ago. He last played in the Davis Cup in November 2019 and reached the final of Wimbledon in 2022, when he lost in four sets to Novak Djokovic.Recently, Nick Kyrgios returned to court in the men's doubles alongside Novak Djokovic. The duo played in the Brisbane International where they beat Austria's Alexander Erler and Germany's Andreas Mies. Their journey as a doubles pair ended with a 6-2 3-6 10-8 defeat by top seeds Nikola Mektic and Michael Venus, who advanced to the qarter-finals.

Kyrgios played in the singles campaign in the tournament as well. Playing his first tournament since a wrist surgery in September 2023, was beaten by Frenchman Giovanni Mpetshi Perricard in a battle of big servers.

### Australia dealt blow as injured Josh Hazlewood set to miss Sri Lanka series

**New Delhi.** Australia have been dealt a significant blow as senior pacer Josh Hazlewood is set to miss the upcoming tour of Sri Lanka due to injury. Hazlewood, who played just two Tests in the recent Border-Gavaskar Trophy against India, will not be part of the touring squad when it is announced later this week, according to The Sydney Morning Herald.

Hazlewood has been hampered by a calf injury and a side strain, which disrupted his participation in the India series. This injury will see him sidelined for the two-Test series against Sri Lanka, which is set to begin on January 29. Hazlewood's absence adds to the list of Australian absentees, as captain Pat Cummins will also miss the tour, leaving a notable gap in the fast-bowling ranks.

With an already packed schedule ahead, including the World Test Championship final against South Africa in June and the Ashes



series next summer, Hazlewood's recovery will be crucial. However, his absence in the Sri Lanka series gives the team more time to focus on his fitness without the pressure of immediate competition. While Hazlewood's fitness will be key for future fixtures, the rise of Scott Boland, who has been outstanding, brings a degree of uncertainty over the team's first-choice attack. Even if Hazlewood were fully fit, he would face stiff competition from Mitchell Starc and Boland for a spot in the starting XI. Australia's place in the World Test Championship final has already been secured, which allows the selectors to be patient with Hazlewood's recovery. The team will likely focus on building a strong squad for the longer-term fixtures. Test in Galle three years ago, is expected to play a pivotal role in the upcoming series. Despite dealing with a hip issue, Cricket Australia is confident that Lyon will be fit for both Tests. # Shubman Gill is highly overrated, India should pick Gaikwad or Sudharsan: Srikkanth

Former India captain Kris Srikkanth slammed Shubman Gill for his performances in the Border Gavaskar Trophy, questioning him for his belowpar contribution.

New Delhi. Former India captain and chief selector Kris Srikkanth has slammed Shubman Gill for his poor performances outside Asia, labelling the Indian No. 3 batter as a "highly overrated cricketer." Apart from Yashasvi Jaiswal, no Indian batter has consistently met the demanding standards required to succeed in Australia. While Nitish Kumar Reddy, Rishabh Pant, and KL Rahul have shown flashes of brilliance, they have struggled to perform collectively when the team needed them the most. Among them, Shubman Gill, often hailed as the next big thing in Indian cricket, has been given substantial support from the selection committee. However, his performances, especially in overseas conditions, have fallen short of expectations, raising concerns about his ability to deliver on the big stage. Gill, who had a breakout debut series in Australia in 2020/21, has struggled to score runs outside Asia since then, averaging just 17.64 across 18 innings. He has failed to cross the 40-run mark even once during this period and endured a disappointing 2024/25 Border Gavaskar Trophy, managing scores of 13, 20, 28, and 31."I've always maintained that Shubman Gill is an overrated cricketer, but nobody listened to me. He is a highly overrated cricketer," Srikkanth said on his YouTube channel.Srikkanth questioned the selectors for persisting with Gill for an extended period while denying similar



opportunities to players like Suryakumar Yadav. Suryakumar was dropped after a single outing against Australia in Nagpur and has since been confined to white-ball cricket. When Gill is getting such a long rope, some people might wonder why even players like Suryakumar Yadav couldn't have been given a longer run in Tests," the former India captain remarked."Suryakumar didn't have the best start in Tests, but he has the technique and ability. Yet, the selectors and management have boxed him into being a white-ball specialist. So now, fresh talent needs to be looked at."Srikkanth urged the team management to consider players like Ruturaj Gaikwad and Sai Sudharsan, who, in his opinion, deserve opportunities ahead of Gill."Ruturaj Gaikwad, for instance, has been performing brilliantly in first-class cricket, but he hasn't been picked. Similarly, Sai Sudharsan has been

outstanding on 'A' tours. These are the players who should be promoted. Instead, the selectors are stuck in a loop with Gill," Srikkanth said."Gill is surviving because he gets ten chances and scores on the tenth after
